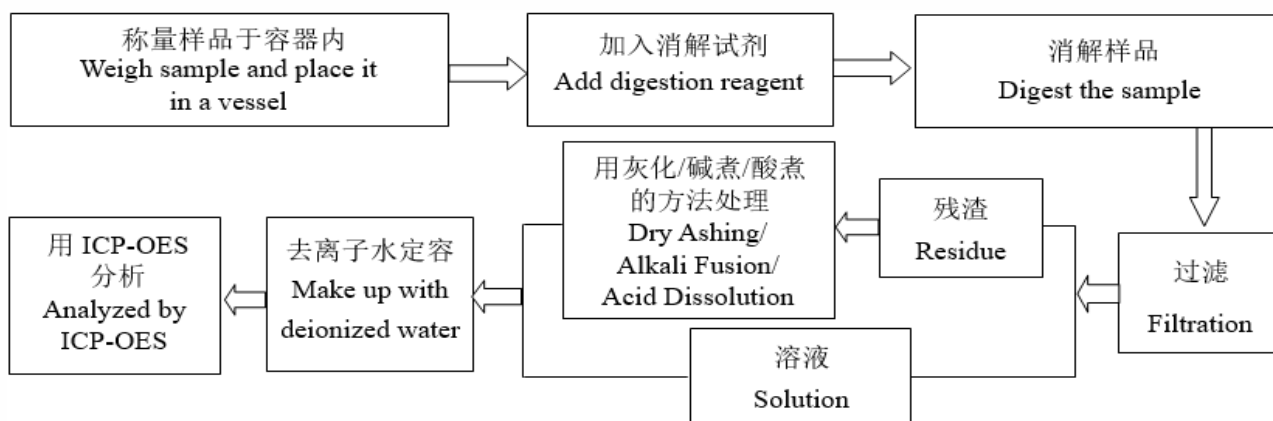

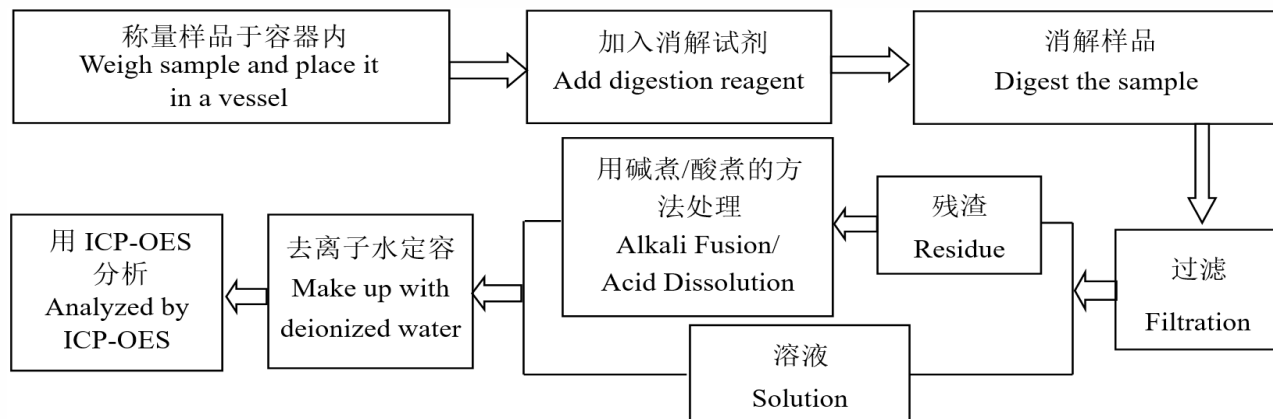

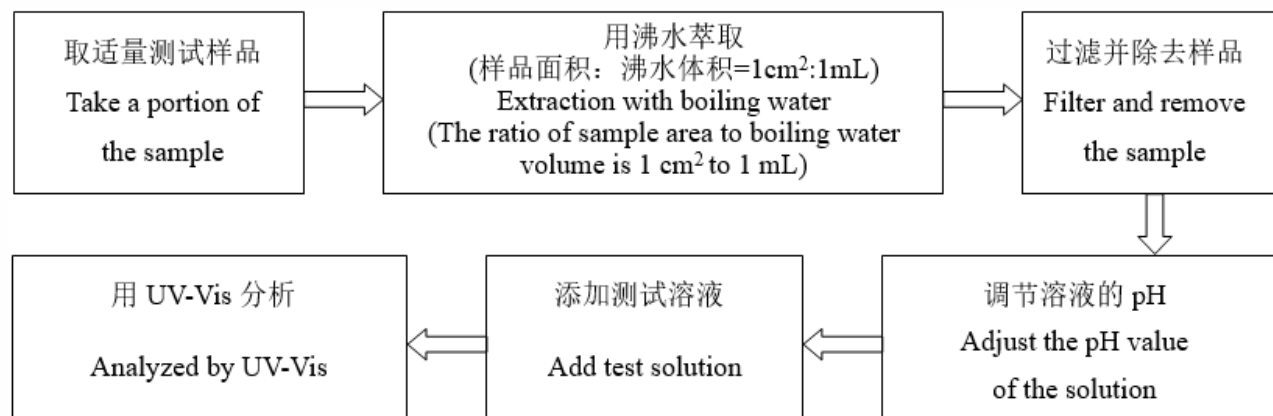


2. 汞 Mercury (Hg)

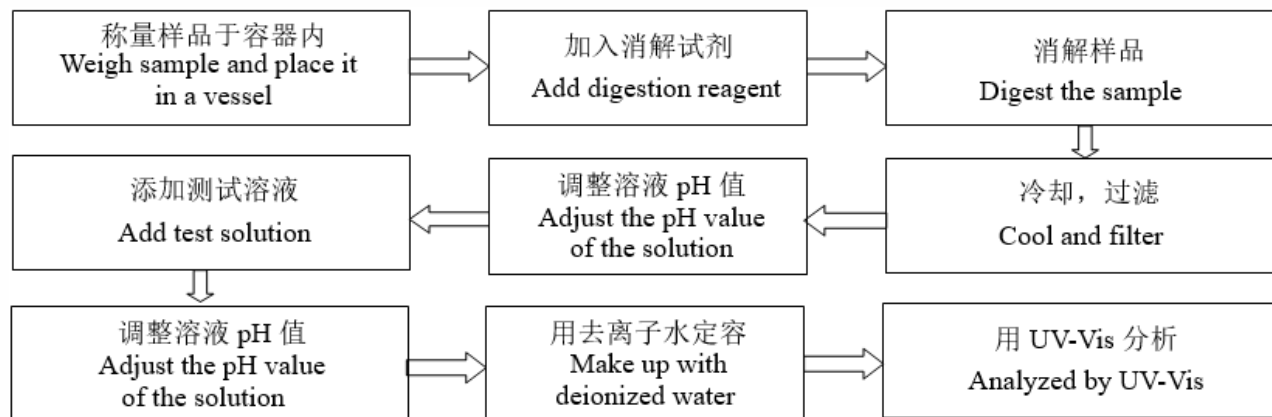

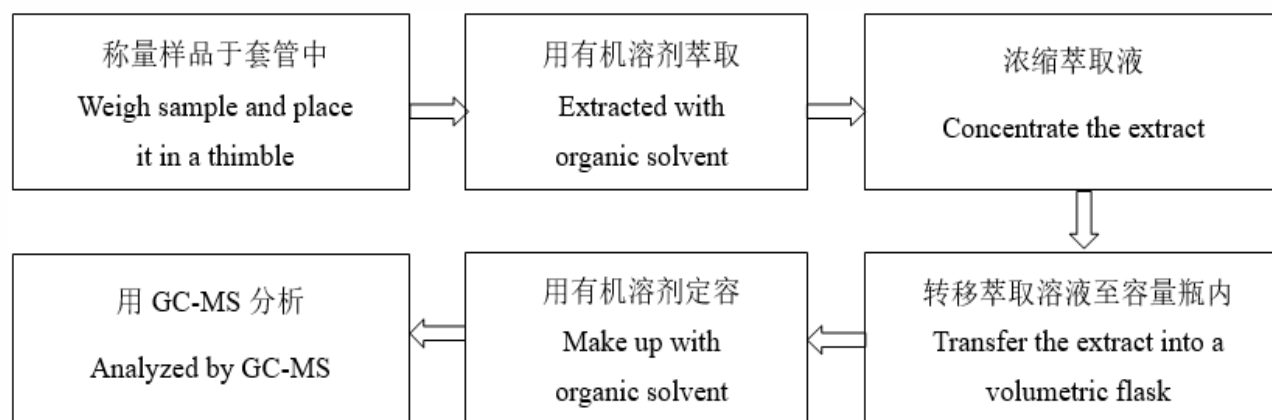

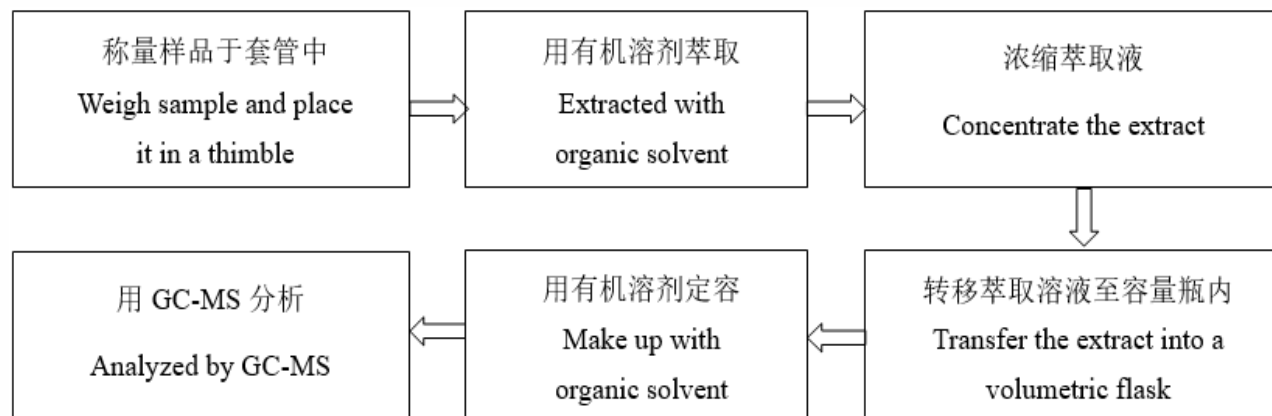

5. 邻苯二甲酸酯 Phthalates (DBP, BBP, DEHP, DIBP)

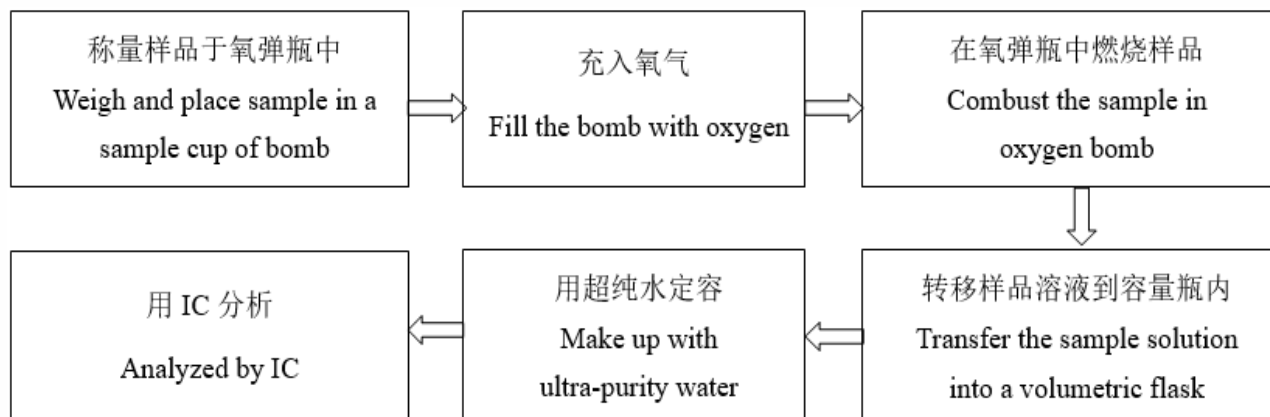
